# CHS farmer-owners, customers and rural communities are impacted by current trade disputes and tariffs

- Tariffs on soybeans and other agricultural commodities hurt U.S. farmers, ranchers and rural communities.
- Trade disputes have already impacted trade flows and the price producers receive for their commodities.
- If tariffs continue, there will be challenges in storing and moving this year's harvest to domestic and international markets.
- There is potential for even greater market disruption if trading relationships between the United States and our key export markets do not improve. CHS also is concerned about the potential for new tariffs to go into effect in the coming weeks.
- CHS is responding by engaging with policy makers, negotiators, producers, customers and value-chain partners. We are working diligently to navigate current challenges and ensure the best possible outcome for our farmer-owners. We are seeking ways to partner with government and industry to develop new markets for agricultural commodities.
